



Contest Requirements and Submission Guidelines

Eligibility

□ Must be 18 years or older and work for an employer located in the <u>Central Perimeter</u> district to participate.

Submission

- □ Submit a video describing your home office dilemma and/or specific improvements that would enhance your telework experience. Areas for improvement could include:
 - Ergonomics: issues related to posture, comfort, sightlines, body position, or furniture.
 - Technology: issues with speed, connectivity, devices, security, and adapting to a paperless workspace.
 - Sensory: issues with distractions, sensory discomfort, and overall wellbeing.
- Email your submission to <u>info@PerimeterConnects.com</u>. Video file may be submitted as an attachment, sent with a large file transfer link (ex: WeTransfer, Dropbox), or provided as a URL to an online hosting site (ex: YouTube).
- □ Emails should include the following:
 - o Name
 - Place of employment (Company name and address)
 - Preferred email address
 - Preferred phone number
- □ Videos should be no longer than two minutes in length and should include:
 - o Your name
 - o Role at a Perimeter business (Mentioning your specific employer is optional)
 - \circ $\;$ Discuss and show the challenges with your home office set-up
 - Identify any perceived home office needs

Winner Selection

- □ Winners will be selected by **April 23rd, 2021**, and will be notified by email.
- Winners will be selected on the basis of (1) the degree and types of their identified home office needs, (2) their comfort, enthusiasm, and engagement with self-filming and communicating experiences in a video format. Winner selection is the sole discretion of the Perimeter Community Improvement Districts.





Participation Requirements

- Submission entrants must agree to participate in a one-on-one recorded (Zoom, Teams, FaceTime, or another collaborative platform) session with a home office & interiors specialist and to self-record videos and photos of their experience with their prize(s). Winners agree that the Perimeter Community Improvement Districts (PCIDs) may use their name, picture, portrait, likeness, and voice for advertising and promotional purposes without further compensation. Entrants agree that all video and photo submissions and recordings become the property of the Perimeter Community Improvement Districts (PCIDs) and may be edited and used at their sole discretion.
- □ Grand prize winners will submit videos of their current office, expert consultation, prize items unboxing, installation, and how they use their makeover items. Prize winners will also provide selfie photos of their experience. These videos and pictures may be used on our website and social media channels.
