

Perimeter Connects Photo Contest Rules

NO PURCHASE IS NECESSARY TO ENTER OR WIN. MULTIPLE CONTEST SUBMISSIONS DOES NOT INCREASE THE CHANCES OF WINNING.

1. Eligibility: This Campaign is open only to individuals who live or work in Perimeter Center and who are 16 years of age or older as of the date of entry and is void where prohibited by law. Employees of Perimeter Connects, its affiliates, subsidiaries, advertising and promotion agencies, and suppliers, (collectively the “Employees”), and immediate family members and/or those living in the same household of Employees are not eligible to participate in the Campaign. The Campaign is subject to all applicable federal, state, and local laws and regulations. Void where prohibited.
2. Agreement to Rules: By participating, the Contestant (“You”) agree to be fully unconditionally bound by these Rules, and You represent and warrant that You meet the eligibility requirements. 3. Campaign Period: Entries will be accepted online starting on **October 15, 2020 9AM EST** and ending **October 30, 2020, 5PM EST**. All online entries must be received by **October 30, 2020, 5PM EST**.
4. How to Enter: Enter by sharing a photo of your bike or a selfie of you with your bike on the Perimeter Connects’ Facebook page: <https://www.facebook.com/PerimeterConnects/>. The entry must fulfill all Campaign requirements, as specified, to be eligible to win a prize. Entries that do not adhere to the rules or specifications may be disqualified at the sole discretion of Perimeter Connects. You may enter only once. You may not enter more times than indicated by using multiple email addresses, identities, or devices in an attempt to circumvent the rules. If You use fraudulent methods or otherwise attempt to circumvent the rules, your submission may be removed from eligibility at the sole discretion of Perimeter Connects.
5. Prizes: Three Winners of the Campaign (the “Winner”) will receive a \$20 REI gift card. No cash or other prize substitution shall be permitted except at Perimeter Connects’ discretion. Perimeter Connects reserves the right, in its sole discretion, to disqualify any individual who tampers or attempts to tamper with the entry process or the operation of the Campaign or website or violates these Terms & Conditions. Participant further waives all rights to have damages multiplied or increased.
